#### Paul's Letter-from Care and Nurture Committee

If any member of the meeting hears of severe need such as suicidal tendencies, we can all be supportive in terms of visitation or listening. Counseling, however, needs to be handled by a professional. Paul Hibschman has a license as a clinician and social worker and requests a letter to identify him as representing the meeting at the local hospital. The clerk read the draft letter for those in hospital training that would allow him to serve Quakers in need of hospital care through both visitation and counseling.

# Minute #3 Friends approved the clerk send a letter to Mission Hospital recognizing him as a representative of the meeting for training in visitation and counseling.

SAYMA Planning and Call for Workshops

Asheville and Atlanta meetings are asked to come up with a plenary activity for Friday evening. A timeline has been set for this plan and the workshop proposal: due date of tomorrow, February 15th. One week of preparation does not seem adequate to the Racial Justice Committee. However, some proposed plans are being discussed. Because we had no representation at the September Representative Meeting, our meeting has not been kept abreast of the developing plans for yearly meeting 2016. One Friend suggested that we communicate with the planning committee regarding this request explaining our having been in the dark about the theme and our involvement. Our meeting representative agreed to talk with Hank Fay regarding our feeling of not being prepared for the input requested by Feb. 15. Racial Justice Committee will be informed of the result of that conversation, and the committee will meet tonight. Regarding workshops, our clerk received the workshop request a month ago. Friends are asked to submit proposed workshops by tomorrow, February 15, 2016.
