Meeting for Worship with Attention to Business Asheville Friends Meeting

Meeting began with a period of silent worship from which clerk, Patti Hughes, read the following:

I have a story to share with you today about Bayard Rustin. Once he spent a weekend doing political canvassing in NYC. He was part of a group of social activists working in the Lower east Side where tall tenements loomed over the narrow streets, filtering out most of the sunlight and darkening the debris-littered sidewalks. He had a canvassing partner for the weekend who shared that for the first part of the day he had difficulty following Bayard because he was erratic in his pattern, changing sides of the street and pausing at almost every intersection. After a while his partner recognized the pattern: Bayard walked only on the sunlit side of the street and lingered for a few moments on each corner where he took pleasure in lifting his face toward the sun. After observing Bayard finding enjoyment in difficult circumstances his partner recognized that Bayard had the strength to survive the abuse and jail sentences he endured as a civil rights organizer in large part because he so deeply cherished the gift of life.

Communications Committee / Steve Livingston

The Communications Committee met last Sunday 8/26/2018, Mike Eddy, Jen Rhode-Ward, and Steve Livingston were present. We want to inform the Meeting that the problem encountered with forwarding of emails from our Meeting's email accounts has been addressed. Friends who wish to offer material for our Meeting website, our Facebook page, or our weekly e-digest can do so by simply replying to the digest mailing, or by emailing either avlfriendsmeeting@gmail.com, ashevillefriendsmeeting@gmail.com, or ashevillefriends@gmail.com. All three addresses will forward to the three active members of the Committee. While all three of us are capable of - and cooperative about - posting to our Meeting's internet presence, we have each taken on principal responsibility for one of them. Jen Ward has primary responsibility for the Facebook page, Mike Eddy for the weekly news digest, and Steve Livingston for the website.

Please be aware that we have not yet discerned what to recommend to the Meeting as guidelines for appropriate content on our website or in the digest. At present we are handling any requests on an ad-hoc basis. However we do have a recommendation for the Facebook page, and we ask that Meeting consider minuting it. Experience tells us that the Facebook page is the most likely place for seekers to have their first contact with the Meeting, and our discernment is that the Facebook page should be a reflection of the life of our Meeting. We do not believe it is in the best interests of the Meeting for the Facebook page to become a sounding board for political issues or a forum for debate. Therefore we offer this Minute to the Meeting: As a reflection of the life of our Meeting, the Asheville Friends Meeting facebook page will be utilized to present a record of the activities, decisions, and concerns of our Meeting community. Friends are encouraged to submit items for publication with the guidance that their contribution would be considered appropriate for rise-of-meeting announcements. We have not yet fully discerned some of the other issues around the Facebook page, such as who has the ability to make an opening post, what are the boundaries of appropriateness for replying to posts, and how we will address violations of future guidelines. As to the first, we will leave that as it is, with Jen as the primary poster, Steve as a backup, and that is all. We will deal with the other questions on an ad-hoc basis as necessary until we can bring recommendations to the Meeting. In general: cordiality, mutual respect, and regard for individuals' privacy and indwelling Spirit describe what we see as natural boundaries. The Committee plans to meet monthly for some time to come, generally on the morning of the first Sunday of the month at 8:30 am. Exceptions will be made for months in which a holiday occurs on the day after that Sunday (as was the case for this

meeting). We are an open committee like most in our Meeting, meaning any Friend with a concern or leading is welcome to attend and participate.
