# Report on Yearly Meeting Sessions and Retreat 2024 of Southern Appalachian Yearly Meeting and Association

July 15, 2024

Friends gathered in Berea, Kentucky on Thursday, June 20th, 2024 as summer commenced and a full moon graced the evening sky. We had an opportunity to begin contemplating the work ahead of us on Racial Conflict Resolution in advance through two zoom meetings with Dr. S Boland; and on each of three days Thursday through Saturday we participated in hybrid sessions on the topic. Ukumbwe Sauti assisted her in the work sessions entitled *Threshing, Sacred Listening, Brave Dialogue* and *Plan for Success, Sacred Steps*. The sessions were handled with care and follow-up, when required, for Friends to begin to heal and become more aware of how racial harm is felt.

Sandwiched around the sessions on Friday through Sunday were meetings for worship followed by meetings for business and worship sharing each morning and workshops each afternoon. Opening worship and evening sing-a-longs bridged the transition to the evening plenaries as follows: a slide-illustrated presentation with Joyce Aljouny, General Secretary of AFSC (American Friends Service

Committee) on the work of that organization regarding the Israeli-Palestinian conflict; Illuminating the path of our Guide to Our Faith and Practice (impromptu skits with Southern Appalachian Young Friends, SAYF and the ad-hoc F&P revision committee); and a dance with a live band.

We ate three times a day in the spacious dining hall on the lower level of the Alumni Center in which many of our activities were held. Those meals sustained us with a variety of options, and as an opportunity to chat, get to know new Friends, and renew our f/Friendships of many years.

Of particular note to monthly meetings is the advice from the ad-hoc assessment committee to raise the assessment from monthly meetings to \$85 per active adult member or attender in the coming year, to \$93 in 2026 and to \$100 in 2027; <u>OR</u> 10% of the meeting's annual income, whichever is the larger amount. This recommendation was based on the inflation rate. We have not raised the assessment in many years. The assessment is \$75 this year and in several years prior to 2023. (SAYMA's fiscal year is October 1, 2023 to September 30, 2024.)

Also of interest and importance to monthly meetings is the minute brought to a business session from Young Adult Friends (YAFs) on the conflict between Israel and Palestine. We are asked to consider the minute and use it, post it, and pass on the minute in various venues including Friends Committee on National Legislation(FCNL). It will be attached to the YM minutes when they are posted.

Nominations brought forward by the Nominating Committee were approved upon the second reading, including that of our new clerk of SAYMA, Jennifer Dickie, Atlanta Friends Meeting. One nomination, brought by Sharon Star Smith on behalf of the Uplifting Racial Justice Committee, to have Star represent the yearly meeting in Friends World Committee for Consultation (FWCC), was not approved. Several Friends expressed that they were not easy having her represent us in that official position. She will, nevertheless, attend the world gathering of FWCC in South Africa, as a delegate next month. Funds were donated to support her going to South Africa outside of the SAYMA budget. Several other delegates from SAYMA meetings will attend. No official representative of SAYMA will attend because of time conflicts (Geeta McGahey, Celo) or resignation (Adrian Mehr, Memphis). We are allowed to have up to three representatives to FWCC as a yearly meeting, usually for a three year term. Friends interested in being a representative can communicate with the SAYMA Nominating Committee.

In addition to transitioning to a new SAYMA clerk, we welcomed a new treasurer, Daryl Bergquist, Birmingham Friends Meeting; assistant clerk, Margaret Farmer, Asheville Friends Meeting; as well as a new employee, Rob Collins, Birmingham Friends Meeting, as Administrative Assistant.

We are grateful to the many people who served on SAYMA committees or in positions of responsibility. It is a broad and fruitful experience to come together as a conglomerate of monthly meetings and worship groups in the Southern Appalachian Mountains.

#### House and Grounds: Nick Mimken & Robin Wells

Doug Lane has received two quotes for painting our fascia/soffits. Both are companies owned by people of color. One, Eric Bautista's, company is the one who painted the outside of our Meetinghouse a few years ago. The other, Rogelio Gomez of Alpha Pro Painting, is a painter that Doug knows well and likes. Bautista quoted \$2,800 and Gomez quoted \$1,700. The job must be primed first. House and Grounds's recommendation is to go with the lower quote of Gomez (Alpha Pro) at \$1,700.

A concern was raised about whether the fascia board is treated or untreated lumber. We may want to treat it differently depending on the answer. H&G, along with Doug Lane, will talk with the concerned Friend about how we will proceed. Doug will consult with Alpha Pro about standard procedures for preserving the fascia. H&G will bring their findings to the August Business Meeting.

#### **Communication:** Mike Eddy

Mike spoke about the possibility of the cost of our internet service going up in the near future. We have not heard anything yet. Mike just wanted us to be prepared.
